## Extension of deadline: Call for offers to host the technical support units for the IPBES task forces

Dear IPBES members, observers and other interested stakeholders,

Please note that the deadline for the call for offers to host the technical support units for the IPBES task forces has been extended to 31 October 2023.

The Plenary, at its tenth session, held from 28 August to 2 September 2023, approved the revised terms of reference of the task forces on capacity-building; on knowledge and data management; on Indigenous and local knowledge; and on scenarios and models of biodiversity and ecosystem services, and requested the task forces to implement their respective workplans approved in decision IPBES-10/1.

In the same decision, the Plenary requested the secretariat, in consultation with the Bureau and in accordance with the approved budget set out in the annex to decision IPBES-10/3, to establish the institutional arrangements necessary to implement the technical support required for the work programme.

I am pleased to herewith invite Governments and relevant organizations to **submit to the** secretariat their offers to host the technical support units for the IPBES task forces, including:

- 1) technical support unit for the task force on capacity-building;
- 2) technical support unit for the task force on data and knowledge management;
- 3) technical support unit for the task force on Indigenous and local knowledge; and
- 4) technical support unit for the task force on scenarios and models.

As stated in the rolling work programme up to 2030 of IPBES, technical support for the implementation of the work programme is provided by the secretariat and, for some of the objectives, complemented by a technical support unit, as appropriate. The secretariat issues open calls for expressions of interest in providing technical support, including in-kind support from Governments and other stakeholders, for the establishment of these units. The most suitable institutions will be selected by the Bureau and will work under the authority of the Executive Secretary (see annex I to decision IPBES-7/1).

Interested Governments or relevant organizations are invited to **submit their offer prepared according to the template provided** <u>here</u>, enclosing the following attachments:

- 1) an application form, using the template provided <u>here</u>;
- 2) a copy of the certificate of registration of the entity which will host the technical support unit; and

3) a copy of the latest audited financial statement of the entity which will host the technical support unit.

The offer should include specific information regarding:

- Relevance of the work of the host institution to the task force;
- Administration and staffing of the technical support unit;
- Funding arrangements, including a budget detailing how the dedicated funds from the IPBES trust fund and the matching in-kind contribution from the host institution would be used.

The offer should be submitted to the secretariat at: <u>mea-ipbes-secretariat@un.org</u>. The new deadline for submissions is: **31 October 2023 (Central European Time)**. The host institutions of the technical support units will be selected by the IPBES Bureau, and institutional arrangements subsequently put in place in line with agreed procedures.
