The Intergovernmental Platform on Biodiversity and Ecosystem Services ([IPBES](#)) will launch its **first-ever 'fast-track' assessment report** on Monday, 9 February 2026 in Manchester, UK.

The IPBES methodological assessment of the impact and dependence of business on biodiversity and nature's contributions to people (known as the "Business and Biodiversity Report") **is expected to be approved at the twelfth session of the IPBES Plenary (#IPBES12, 3-8 February 2026)** by representatives of the 150 member Governments of IPBES.

The culmination of almost three years of work by **80 of the world's leading experts** from science and the private sector, as well as from Indigenous Peoples and local communities – drawn **from 35 countries** – the Report **aims to provide information and options that can be used by businesses and financial institutions to drive better outcomes for biodiversity and nature's contributions to people.**

What is a 'fast-track' assessment? One that has been completed in a shorter time than other IPBES assessments. Typically, this entails two years of work (compared to four), two meetings of all the authors (compared to three) and a single round of external expert review (compared to two).

Expected impacts

The IPBES Business and Biodiversity Report will:

- Provide decision-makers, including Governments, businesses and the financial sector with the critical information necessary to best measure the dependencies and impacts of business on biodiversity and nature's contributions to people
- Inform more integrated business and financial decisions and actions to simultaneously achieve the SDGs, the Global Biodiversity Framework and the Paris Agreement
- Recognize and emphasize the role different actors have in addressing these challenges

The **primary audience** of the Report includes **governments at all levels, businesses and financial institutions**. It will also have significant value to **consumers, civil society, Indigenous Peoples and local communities** in their interactions with businesses. The evidence and options highlighted by the Report will promote business accountability and transparency, improve producer and consumer knowledge of impacts and dependencies on nature, and will also inform finance and investment decisions.

Often described as the '[IPCC](#) for Biodiversity', IPBES is the global science-policy body tasked with providing the best-available evidence to decision-makers, for people and nature. IPBES assessment reports **respond directly to requests from governments and decision-makers** – making them immediately relevant around the world.

Important aspects of the Business and Biodiversity Report

The conservation, restoration and sustainable use of nature is not just an environmental goal – it is an essential component of sustainable, successful business. Nature's economic contributions, though critical, are often overlooked and undervalued. The rapid expansion of economic activity, without proper attention to its negative side effects, has taken its toll on nature, which in turn poses serious threats to business.

Building on the work published by IPBES over the last decade, the Business and Biodiversity Report:

- Categorizes the dependencies and impacts of businesses and financial institutions on biodiversity and nature's contributions to people – offering typologies of the different business sectors, dependencies and impacts (both direct and indirect) of businesses and financial sectors
- Highlights the collaborative actions with Governments at all levels, consumers, civil society, Indigenous Peoples and local communities that are required to promote an enabling environment for business to address impacts and dependencies on nature
- Evaluates approaches for measuring and reporting on these impacts and dependencies – providing an inventory of methods across types and levels of decision-making for better decisions
- Identifies actions that can be taken by businesses to directly support the achievement of the Sustainable Development Goals (SDGs), the Paris Agreement and the Kunming-Montreal Global Biodiversity Framework

Structure of the Business and Biodiversity Report

In addition to a short Summary for Policymakers, the Business and Biodiversity Report comprises **six chapters**:

1. *Setting the scene*, including a typology of different business sectors that depend on and impact biodiversity (formal and informal)
2. *Business dependencies on biodiversity*, exploring a typology of the wide variety of methods and approaches to identify dependencies of businesses of different types and sizes – providing concrete examples and noting potential synergies and trade-offs with other societal goals
3. *Business impacts on biodiversity*, offering a typology of impacts across direct, value chain and indirect impacts, pathways of impacts, and estimates of the impact of different business sectors
4. *Measuring dependencies and impacts*, assessing approaches for measurement (including frameworks, metrics, indicators, models, data and tools- with an inventory of methods).
5. *Options for action for businesses*, describing potential options for ways businesses can use measurement of dependence and impact in their operations to improve social, economic and environmental performance, providing specific examples of collaboration within and across sectors
6. *Options for action for Governments, the financial sector and civil society*, in their interactions with business to create an enabling environment through, among others, policy, procurement, governance, lending and investment, insurance and monitoring

Reviewers

To ensure the highest-possible levels of accuracy, credibility and policy-relevance, the IPBES Business and Biodiversity Report has been extensively reviewed through an open and transparent external review process, with thousands of external review comments submitted by scientists, businesses, decision-makers (including Governments), practitioners and holders of Indigenous and local knowledge.

3-Year TIMELINE

July 2022	The IPBES Plenary, comprising representatives of IPBES member Governments, approved the ' scoping report ' establishing the roadmap for the assessment.
Jul- Sep 2024	External experts reviewed the first draft of the report, with review comments addressed in the subsequent drafts by IPBES experts.
May - Jun 2025	Additional Government review of the summary for policymakers. These comments have been addressed in the final text by IPBES experts.
February 2026	Consideration by member Governments at #IPBES12 Plenary session of final text of the Summary for Policymakers in Manchester, UK, followed by the planned media launch scheduled for 9 February 2026.
